The Office of the Ombudsperson is WWF's independent mechanism for raising environmental or social concerns about WWF's activities which may affect you or your community.

The Office is part of WWF's Environmental and Social Safeguards Framework, and provides a voluntary, non-adversarial and impartial process to meaningfully and fairly address your concerns.

You may use this form to submit a complaint to the Office of the Ombudsperson. Please complete the details below and email it to <a href="mailto:info@wwfombudsoffice.org">info@wwfombudsoffice.org</a>, or send it by mail or deliver it to any WWF office, or give it to a trusted WWF staff member who can help to channel your complaint to the Office.

Your complaint will be treated as confidential unless you provide explicit consent for it to be shared. The Office does not share the complaint or complaint information, including your personal data, without consent, including with WWF staff or management outside of the Office. Personal data shared via a complaint will be treated in accordance with the Office's <a href="Privacy">Privacy</a> <a href="Privacy">Policy</a> (https://www.wwfombudsoffice.org/wwf\_privacy/).
